I. CONSENT AGENDA ITEMS FOR CONSIDERATION AND APPROVAL

II. CORRESPONDENCE AND SPECIAL RECOGNITION

C. Fire Department Operations

1. Fire operations report: incident counts, types, and response times.
 - a) The report for fire operations was presented for January 2021. Included in the report were the incident counts, types, and response times.

D. Emergency Medical Services / Ambulance Operations

1. Ambulance operations report: incident counts, types, and transports.
 - a) The ambulance operations report was presented, which included the number of incidents, types, and transports for January 2021.

1. Fleet/apparatus report.
 - a) An update was given on the Plymovent exhaust issues, at this time the matter is under observation.
2. Buildings/facilities report.
 - a) An update was given on the progress of repairs at Fire Station 132. Currently no work will begin at Station 132 prior to permits being obtained.

G. Public Education/Community Outreach

1. Prevention volunteer service anniversaries – No anniversaries were presented.
2. Prevention volunteer hours summary.

- a) The report for the summary of volunteer hours was presented for January 2021.
- 3. Community relations program report.
 - a) The community relations report was given for January 2021. There were 81 citizens served by fire prevention. Currently lock boxes are scheduled out through January 2021.
- 4. Community events – No community events were presented for January 2021.

H. Fire Prevention

- 1. Fire prevention inspection summary.
 - a) The reports for the annual summary and construction inspections were given for January 2021.
- 2. Permits issued and revenue report.
 - a) The report for permits issued and revenue received was presented for January 2021. The total revenue amount received was \$6,882.36, which included revenues from lock boxes and contractor fees.

 - a) There were 2 formal fire investigations for January, the result of both fires was undetermined.
- 4. Large community projects.
 - a) An update was presented on the Banner Boswell Medical Center Tower and pending permits. The Emergency building is currently in operation.
 - b) The large community projects within the Sun City District are currently ongoing. The following recent projects are Royal Oaks Campus, AAA Auto, Bank of America, Heritage Condos and Clubs on Grand II.
 - c) An update was given on the Ridgeview subdivision and Public Library Expansion projects in Youngtown. Both projects are currently under construction.
