BUSINESS CONDUCTED: The Committees of the Board discussed various matters within their areas of responsibility.

I. Legal and Insurance

II. Budget and Finance
A. Finance Director Gabe Buldra prepared a packet with the summary results of the Request for Proposal (RFP) for collection services for ambulance billing. Five collection companies were solicited, and three companies submitted proposals. Proposals were received from the following companies: Professional Credit, IC System, and Sierra Collections and Consulting LLC. Mr. Buldra was unable to make today's meeting and the board had questions pertaining to contract length, collection rate, and financial hardship requests. Chief Schmitz was able to address some of their concerns and Mr. Buldra will be at next week's board meeting to help answer any remaining board questions and concerns.  - B. A Request for Proposal (RFP) was submitted to three apparatus manufacturers and all three submitted proposals. The manufacturers were E-One, Sutphen, and Pierce. Copies of the proposals were given to the board to review. The department's apparatus committee will be meeting this week to review the proposals and make a recommendation to the board. This item will be placed on the regular board meeting as a possible action item.
